### Appropriations Committee Approves Baltimore City School Construction Bill with Amendments

Last night the Appropriations committee considered and adopted amendments to HB 860, the Baltimore City Public School Construction Revitalization Act. These amendments changed the mechanics of how new and renovated schools will be financed and constructed, but still maintains the original intent of establishing a financing mechanism to address the critical facilities needs in Baltimore City Public School buildings and provides the first \$1.1 billion for Phase I of the 10-Year Plan. The bill recognizes the unique position of Baltimore City School buildings and prescribes three main actions to address their deteriorating condition:

#### Establishes a partnership between the State, Baltimore City, and Baltimore City Public Schools:

- Each entity contributes \$20 million annually to a facilities fund to replace or renovate inadequate school buildings in Baltimore City;
- Funding streams such as the Beverage Container Tax, lottery proceeds, and a new State Aid to Education intercept will provide financial backing to support up to the first \$1.1 billion of the plan.

#### Leverages the experience and capacity of the Maryland Stadium Authority (Authority) to oversee the construction and revitalization of Baltimore City Public School Buildings:

- The Authority replaces the proposed Baltimore City School Construction Authority as the coordinator for the construction

- The Authority is empowered to act on behalf of Baltimore City Public Schools to acquire, construct, or improve public school facilities;
- The Authority is authorized to finance the construction and revitalization program.

**Establishes a process for accountability and reporting:**

- Ensures all school buildings will continue to be reviewed and approved through the current state process with the Interagency Committee on School Construction (IAC) to safeguard quality;
- Requires the Authority to seek Board of Public Works approval before issuing bonds and to report on the progress of the program to the Maryland General Assembly each year;
- Prescribes a four-party Memorandum of Understanding, that details roles and responsibilities of Baltimore City, City Schools, the IAC, and the Authority.
