City Leaders and Advocates Unite in Support of the Block Grant Bill!

On October 16, nearly 300 parents, teachers, clergy, and community leaders representing over 60 organizations from across the city joined the <u>Baltimore Education Coalition</u> (BEC) in getting on board the <u>Transform Baltimore</u> "Block Grant Express." The event demonstrated the unity and support of City leaders as School Board Commissioners, State Delegates and Senators, and City Council members came to the event to show their support of efforts to rebuild or renovate all City schools. These leaders were the first to get on board the "Block Grant Express" when they proclaimed the passage of the Block Grant bill the top priority for the General Assembly in 2013.

The State Block Grant is a key component in the financing plan to fully rebuild and renovate all city school buildings within 10 years. City Schools recently completed a comprehensive analysis of school facilities deemed the "Jacobs Report" that gave City school facilities an "F" for educational adequacy and estimated a \$2.4 billion cost to fix the buildings.

"Every day we send our children into the world and pray that their spirits won't be broken like the buildings they're expected to learn in... These buildings have lied about who you are for far too long," said Arica Gonzalez, Co-Chair of the event. "Tonight we let you know that you are our priority and we will not devalue you any longer." The evening included performances by student groups and a rousing teaching that invited everyone to get on board the "Block Grant Express" to pass the bill this legislative session!

PCAB reviews the policies and procedures of Baltimore City Public Schools and advises the School Board of Commissioners and City Schools staff on education reform efforts.
