How to interpret NCIC "hits" relating to ICE Warrants

NCIC ENTRIES

- There are different types of NCIC entries related to illegal immigration.
- A majority of NCIC entries are related to civil / administrative violations of federal immigration laws.

- Local Law Enforcement agencies are not permitted to arrest, detain, civil / administrative warrant in NCIC. hold, delay a contact with a subject to investigate further an open
- These types of civil / administrative warrants are not issued by a federal court / judge but by ICE themselves.

Deported Felon NCIC entry

Some entries into NCIC are to alert Law Enforcement that they are dealing with a Deported Felon. These alerts are not criminal arrest warrants even though it prompts contact be made to ICE.

1.2.4 Bias-Based Profiling

Definitions:

- background, gender, sexual orientation, religion, economic status, age, cultural group, motorcycle group, immigration status, or any other identification group. Biased-Based Profiling - The selection of individuals based solely on a trait common to a group for enforcement action. This includes, but is not limited to, race, ethnic
- Enforcement Action Activities both on and off duty, undertaken by Office personnel that arise from the authority related to employment, oath of office, state statute, Federal law or county ordinance. Activities such as traffic contacts, field contacts, arrest, investigations, searches, asset seizure and forfeiture, and general law enforcement contact with citizens.

1.2.5 Immigration Status

Definitions:

- Immigration Status The status of a person as it relates to being present in the United States either legally or illegally.
- Enforcement Action Activities, both on and off duty, undertaken by Sheriff's Office Law Enforcement Bureau personnel that arise from the authority related to employment, oath of office, state statute, or county ordinance, including activities such as traffic contacts, field contacts, arrests, investigations, searches, asset seizure and forfeiture, and general law enforcement contact with the public we serve.
- The Sheriff's Office Law Enforcement Bureau prohibits employees from inquiring about a person's immigration status during any Law Enforcement activity to include but not limited to: traffic contacts, field contacts, arrests, investigations, and general law enforcement contacts with the public we serve.

74.3.6 Immigration Warrants

- It is the policy of the Frederick County Sheriff's Office Law on an Immigration warrant for deportation. This includes Civil or Administrative warrants related to an individual's citizenship in the Enforcement Bureau not to arrest or detain an individual based solely United States
- The Sheriff's Office will provide training in regards to NCIC records to Civil and Administrative warrants. received from the U.S. Immigration and Customs Enforcement related
