Full "Kirwan" Commission Meeting this Thursday!

Thursday, June 28, 2018 9:30-5:00 p.m. Room 120, House Office Building Annapolis, MD

This Thursday, join us for a full "Kirwan" Commission on Innovation and Excellence in Education meeting in Annapolis. While all of the meetings are important to attend, this is one not to miss. In the morning, commissioners and audience attendees will hear from expert panelists on race equity, community-based health, mental health, and social services for school-age children, and more.

Two panelists we would like to highlight are Dr. Ivory Toldson and Bronywn Mayden, MSW. Dr. Toldson, president and CEO of The Quality Education for Minorities Network and former head of the White House Initiative on Historically Black Colleges and Universities, is a national expert on educating students of color and building channels for postsecondary success. Dr. Toldson will address issues related to racial equity that the Commission should consider. Bronwyn Mayden, MSW, is an Assistant Dean at University of Maryland's School of Social Work and Executive Director of Promise Heights, a cradle-to-college-to-career program in the West Baltimore neighborhoods of Upton and Druid Heights. Ms. Mayden will speak to the Commission about school-based social and health services.

Although the morning session (9:30am – noon) of the full Commission will be livestreamed <u>here</u>, the afternoon working group meetings will not. The afternoon Working Groups (12:30pm-4pm) are open to the public. **Audience members have had the opportunity to directly participate in the discussions so your attendance is encouraged.**
