Strong Support for Spending on School Construction Results of Baltimore Sun Poll

Did you miss this story during the hurricane (as we did)? A recent Sun poll shows that 79% of Baltimore voters want at least half of the City's share of slots revenue to go to school construction! Only 14% want it used solely for property tax reduction. About half of the respondents want to divide the slots revenue equally between building schools and reducing property taxes.

This is a strong message from City residents about the need to use new revenue to modernize Baltimore's crumbling school buildings!

President Obama Proposes \$25 Billion to Fix America's Crumbling Schools

New jobs plan also recommends \$30 billion for teacher layoff prevention

What is the federal government doing to help modernize dilapidated school buildings? On Thursday evening, President Obama proposed the "American Jobs Act," a \$447 billion plan to bolster economic recovery, build infrastructure, and create new employment opportunities. The plan, should it be adopted by Congress, includes a \$25 billion initiative to renovate 35,000 public school buildings. This includes severely needed emergency repairs, greening and energy efficiency upgrades, as well as new science and computer labs. Forty percent of the funds would be directed toward the 100 largest high-need public school districts which would likely benefit Baltimore City. Baltimore County, and Prince George's County. The other sixty percent of the funds would go to states to allocate flexibly.

As the ACLU argued in the 2010 study, *Buildings for Academic Excellence*, the President suggests that increased investment in school modernization will create jobs in a variety of industries, especially construction and engineering. In addition, the plan calls for \$30 billion to prevent the layoff of up to 280,000 teachers and hire thousands more. The money would help school systems avoid cuts affecting children, such as increasing class sizes.

An increased federal role in school construction is critical to meet the huge need, particularly in low-wealth jurisdictions. Advocates must mobilize to get support in Congress to pass the President's proposal!
