# Pre-Kindergarten: A State Mandate and ACLU Action

The ACLU has been actively working with the Baltimore City Public School System (BCPSS), the Maryland State Department of Education and other local school systems statewide to advocate the importance of meeting the Bridge to Excellence in Public Schools Act mandate for pre-Kindergarten. The law states that all public school systems must provide at least a half-day of prekindergarten to low-income and homeless four year-olds (must be 4 years old by Sept. 1st). The ACLU is working to ensure that all eligible children are provided seats and the systems are in compliance with the law.

# Grant Available Soon for Community-Based Organizations

Currently, Baltimore City's school system is limited in its ability to leverage existing relationships and organizing capacities among the city's rich network of community-based organizations. The network of relationships that these groups can mobilize is a powerful resource for our schools and can complement school activities in new and effective ways. The Baltimore City Public School System is going to provide a grant to community organizations to increase parent and community participation to address these issues:

- Improve student academic success
- Increase parent participation and form new PTA groups
- Increase enrollment of Free and Reduced Meal students
- Ensure students and parents understand school choice and college access
- Increase student attendance by direct outreach to families
- Establish/reinforce school safety strategies
- Support school strategy to develop external partnerships

Applicants may apply for a partnership with one school or a cluster of schools. Grant requests must not exceed an estimated average of\$12,000 per school served. Funding is contingent upon availability and qualifications.

Peer-to-Peer Enterprises has asked the Mayor for \$3 million in the city budget for their programs. These programs would create700-1,000 youth jobs in the knowledge-based economy and the goal is both to create youth employment and to develop the city's human capital. Some of these well-established groups include the Algebra Project, the Baltimore Urban Debate League, and Kids on the Hill, which provide a range of services to teens such as Algebra tutoring, training in film/media work, and developing skills in debating.
