Dear Governor O'Malley:

We, the undersigned civil and human rights organizations, faith-based groups, legal service providers, and law professors write to thank you for your courageous response to the unfolding child refugee crisis. We applaud your statement that "[w]e are not a country that should turn children away and send them back to certain death," and we wholeheartedly support your efforts to find shelter for them in Maryland. We write now to offer our help and to reaffirm the importance of ensuring that any chosen sites be appropriate for children and as close as possible to legal service providers and supportive community organizations.

Like you, we strongly believe that the best arrangement for unaccompanied children is to send them to relatives living in the United States while their immigration cases proceed and, if no relatives are available, to place them in foster homes or to provide temporary housing in a humane setting appropriate for children. We reiterate our firm belief that any site in Maryland should genuinely be a *shelter*, not a detention center euphemistically referred to as a shelter. To that end, we support your effort to continue looking for child-appropriate locations that are the least restrictive and most humane possible, where education and services can readily be provided, and where the children are nurtured and protected.

We also emphasize the importance of proximity to legal service providers, in order to minimize the number of children who are forced to appear in immigration court unrepresented, and to community organizations, in order to facilitate access to as much programming and community support as possible. And we firmly agree with you that they should not be placed in parts of the state where they may be exposed to targeting and harassment by local residents.

We thank you again for your leadership on this issue. You have had the integrity to recognize this crisis for what it is: a situation that requires our compassion and help, not an inconvenience to be resolved by shipping refugees back to violent and dangerous situations without proper consideration of their claims to asylum or other legal relief. And, in contrast to the xenophobic responses fleeing children have received elsewhere, you are ready to welcome them into our state. We stand ready to offer our assistance and support.
