## HELP STOP CUTS TO EDUCATION! Email your legislators today

STOP EDUCATION CUTS! EMAIL YOUR LEGISLATORS NOW!

The Governor's budget proposes over \$100 million to be cut from Maryland schools, including cutting \$31 million dollars from current funding to Baltimore City schools.

What \$31 million dollars means for City Schools:

Increase in class size \* Fewer school staff: teachers, social workers, art, & after school
programs are likely to be affected \* Less money to repair boilers and keep the heat on!

These cuts will affect Baltimore City more than some wealthier districts because of the larger number of at-risk students enrolled. Don't turn back the clock on the City Schools progress! The Bridge to Excellence or "Thornton" was passed to provide an adequate education to each child-tell your legislators not to change the Thornton law!

#### Our Request for Obama's Economic Stimulus Plan

- \$20 billion minimum for school facilities; this could generate up to 250,000 jobs
- · Allocated according to Title I; could bring \$90 million to city schools · Funds allocated directly to the largest and lowest-income districts; for high impact on jobs and stimulating the economy
- · States must not supplant current funding to districts; all states must maintain current levels of school facility funding so that more Improvements can be done and for the creation of more jobs
- · Flexibility and strict reporting to assess impact for future federal investments
