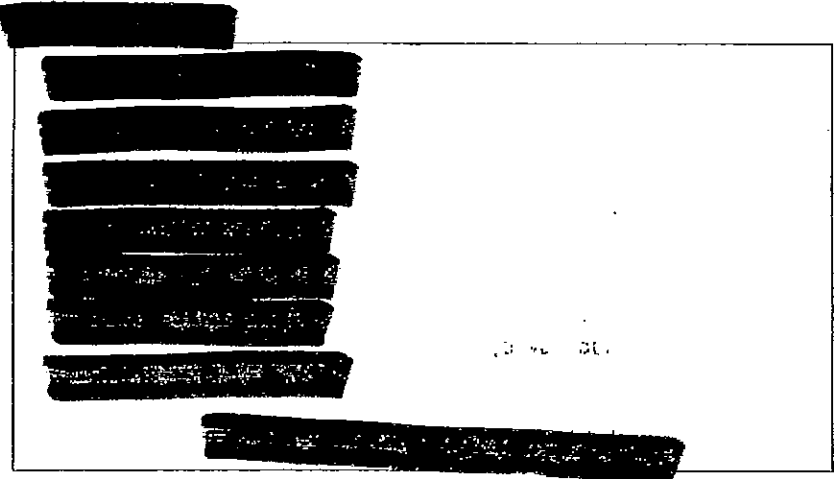

[REDACTED] information was obtained by I/A [REDACTED] that a new anti-war group, Peace Action Montgomery (PAM), was planning to demonstration against a Maryland Defense Contractor Lockheed Martin Corp. at it's Bethesda Maryland Headquarters, on December 22, 2006.

[REDACTED] PAM is an anti-war protest group that appears to have been formed or at least became visible, within the last few months.
