



ACLU of Maryland Social Media Policy

Here are the rules for the ACLU of Maryland social media accounts:

1) User must be respectful of other people's views. Disagreement is normal when talking about issues that people care deeply about. However, if a user repeatedly violate these rules by posting comments, images or videos that are:

- Advertisements, promotions, or solicitations of a commercial product or service. Spam, i.e., large volumes of unnecessarily repetitive content.
- Confidential, personally identifying, or private information as defined by state law.
- Unlawful obscenity.
- Threats of physical or bodily harm.

Then, the ACLU of Maryland reserves the right to either hide the comments, report the user and/or temporarily or permanently block that person from the page if their problematic posts and comments persist.

2) Don't post about personal legal questions, cases or inquiries. Requests for assistance are accepted on our Civil Rights Complaint Line. The line is in operation on Tuesdays and Thursdays between 1:00 and 3:00 pm. The phone number is (443) 524-2558. Remember the ACLU of Maryland receives a high volume of requests for help.

Here are the rules for the ACLU of Maryland Facebook Group:

The activists must agree/and have their activity in the group be guided by the ACLU of Maryland's mission "that all people in the state of Maryland are free to think and speak as they choose and can lead their lives free from discrimination and unwarranted government intrusion."
